

### **Mortgage Contribution (based on actual mortgage)**

1. This offer is available between 11<sup>th</sup> May 2026 and 17<sup>th</sup> May 2026 (both dates inclusive) (“**the Offer Period**”) on **Plot 31** at Charles Church (Moat House Grange, Bedworth) [in our Central operating company area], subject to customer status and availability. In these terms “**You**” means the customer(s) and applies if the relevant Charles Church home is being acquired by one or more persons. “**Us**” and “**Our**” are references to Charles Church. “**The Offer**” means the offer detailed in paragraph 3 below. The provision of the Offer is strictly subject to these terms and conditions. “**We**” means Us and You.
