

## **Mortgage Contribution (based on actual mortgage)**

1. This offer is available between 9am GMT 19/05/26 and 5pm GMT 16/06/26 (both dates inclusive) (“the **Offer Period**”) on selected Charles Church developments and plots only West Wales operating company area, subject to customer status and availability. The term “**Price**” means (in these terms and conditions) the release list price for the relevant plot disregarding the cost of any extras or finishing touches You may order from Us. In these terms “**You**” means the customer(s) and applies if the relevant Charles Church is being acquired by one or more persons. “**Us**” and “**Our**” are references to Charles Church. “**The Offer**” means the offer detailed in paragraph 3 below. The provision of the Offer is strictly subject to these terms and conditions. For the avoidance of any doubt if You comprise more than one person and either or any of You withdraw from the purchase of the Persimmon home, the person(s) so withdrawing shall not be entitled to the Offer.
2. Our sales representative will let You know in writing, during the Offer Period whether or not You potentially qualify for this Offer (qualification would ultimately remain subject to these terms and conditions) . To qualify for this offer You need to have entered into a reservation agreement with Us (which includes the payment of the required reservation fee) for the specific Persimmon home to which Our Offer relates no later than 5pm GMT 16/07/26 (time being of the essence).
3. The Offer will be calculated on the basis of the actual mortgage offer that You intend accepting (We will need to see evidence of the projected payments from your financial advisor or lending institution prior to legal completion). The Offer is that We shall “contribute” to Your mortgage (by way of an allowance on the Price (see Clause 6 below)) and this “contribution” shall be equal to the first 12 average monthly mortgage payments you will be due to make. Notwithstanding the foregoing the financial incentive available to You shall not exceed a sum equating to 5% of the Price and the maximum monthly mortgage payment to qualify for the offer shall be £2,230 (Our “contribution” shall be calculated taking into account that monthly cap)
